Under no circumstances shall delivery of the BIM model for use by you be deemed a sale by Lionakis, and Lionakis makes no warranties, either express or implied, of merchantability and fitness for any particular purpose. In no event shall Lionakis be liable for any loss of profit or any consequential damages as a result of your use or reuse of the BIM model. The BIM model shall be in Revit 2020.
