## Sacramento City USD Board Policy Uniform Complaint Procedures

BP 1312.3 Community Relations

The Governing Board recognizes that the district has the primary responsibility to ensure compliance with applicable state and federal laws and regulations governing educational programs. The Board encourages early resolution of complaints whenever possible. To resolve complaints which may require a more formal process , the Board adopts the uniform system of complaint processes specified in 5 CCR 4600- 4670 and the accompanying administrative regulation.
The district's uniform complaint procedures (UCP) shall be used to investigate and resolve the following complaints:
1. Any complaint alleging district violation of applicable state or federal law or regulations governing adult education programs, after school education and safety programs, migrant education, career technical and technical education and training program s, child care and

A student enrolled in a district K 12 school shall not be required to pay a pupil fee for participation in an educational activity.
All of the following requirements apply to the prohibition identified above:
1. All supplies, materials, and equipment needed to participate in educational activities shall be provided to students free of charge.
2. A fee waiver policy shall not make a pupil fee permissible.
3. The district shall not establish a two tier educational system by requiring a minimal educational standard and also offering a second, higher educational standard that students may only obtain through payment of a fee or purchase of additional supplies that the school district or school does not provide
4. The district shall not offer course credit or privileges related to educational activities in
exchange for money or donations of goods — or services from a student or a student's— parents/guardians, and a school district or school shall not remove course credit or privileges—

where applicable, includes reasonable efforts by the district to identify and ensure full
reimbursement to all affected students, parents/guardians who paid a student fee within one year prior to the filing of the complaint, subject to procedures established through regulat ions adopted
by the state board. (5 CCR ´§ 4600(u))
Information regarding the requirements of this pupil fee law shall be included in the annual
notification distributed to students, parents/guardians, employees, and other interested parties pursuant to 5 CCR 4622.
The district shall establish local policies and procedures to implement the provisions of this law. (Education Code 49011 — 49013)
The district shall have the primary responsibility to insure compliance with applicable state and federal laws and regulations. (5 CCR 4620)
The district shall investigate complaints alleging failure to comply with applicable state and
federal laws and regulations and/or alleging discrimination, harassment, intimidation and/or bullying, and seek to resolve those complaints in accordance with the district's Uniform
Complaint Procedures. (5 CCR 4610, 4620, and 4621)
