This letter serves as Sacramento City Unified School District's (the "District" or "SCUSD") nineteenth update regarding corrective actions outlined in the California Department of Education's ("CDE") January 19, 2021 Investigation Report ("Decision") for Case S-0297-20/21:

**Eqt tgevxg'Cevkqp'3:** The student disenrolled from the Sacramento City Unified District on February 17, 2021. An exchange of information form has been sent to the guardian to request their consent to obtain copies of the assessment reports and initial IEP document once completed in the newly enrolled school district. To date the District has not obtained a signed exchange of information. SCUSD team members continue to reach out to the guardian to request their consent to the exchange of information.

**Eqt tgevxg'Cevkqp'4:** Completed, submitted, and pending CDE's final review.

**Eqt tgevxg'Cevkqp'5:** The recorded training for the District's special education assessment administrators, school site special education case managers, and assessment service providers was provided to staff with a verification survey link. The District continues to send reminders to watch the training and has provided an updated verification of attendance for the month of May.
